Improvement Plan Focus Area: Literacy		
 Priority Area: Based on the identified focus area, what issue needs to be addressed to achieve the goal? The majority of students are not reading at grade-level. Lonoke Elementary School needs to address that nearly 55% of students are not proficient readers. (Specially vocabulary and comprehension are weaknesses) 	Team Member(s) Responsible: Principal, Jennifer Holland Building Admin Team Leads Literacy Teachers	
Desired Outcome: When fully implemented, what will be different as a result of addressing this priority? All Students at each grade level will increase reading proficiency by 10% according to data from IReady and Atlas.		

Root Cause(s): What is the heart of the issue? What evidence supports this conclusion? Based on 2022-23 ACT Aspire scores, only 38% of students grades 3-10 are reading at grade level. Students are not exposed to high quality, grade level reading instruction with rigor and fidelity.

As of June 1, 2024, based on iReady End of Year scores 45 % of students grades 3-5 are reading at grade level. 43% of 3rd Grade students are not reading on grade level. 4th Grade has 54% not reading on grade level. 5th Grade has 66% not reading on grade level. We need to increase the level of high quality grade level reading, instruction, and Tiered intervention with rigor and urgency.

Priority #2 Improvement Plan Focus Area: Math		
Desired Outcome: When fully implemented, what will be different as a result of addressing this priority? Math proficiency will increase by 10% for all students, as noted on IReady and Atlas.		

Root Cause(s):

According to the 2022-23 ACT Aspire, only 37% of students grades 3-10 are performing at grade level. Students are not exposed to high quality, grade level math instruction with rigor and fidelity.

As of June 1, 2024, based on iReady End Of Year scores 46% of students grades 3-5 are performing Math standards on grade level. 44% of 3rd Grade students are not performing Math standards on grade level. 4th Grade has 59% not performing Math standards on grade level. 5th Grade has 60% not performing Math standards on grade level. We need to increase the level of high quality grade level math instruction, and Tiered intervention with rigor and urgency.
