The Allied Therapy charges have increased for the upcoming year. See changes below:

- OT, PT, ST - \$10 increase per therapy hour
- OTA, PTA - \$16 increase per therapy hour
- Evaluations - \$6 increase per hour
- Monthly Monitor - \$10 increase

Medicaid will increase reimbursements at a rate of 16% beginning July 1, 2022. Medicaid will reimburse \$25.24 per service unit which is an increase from \$21.76 per unit this current school year.
