AFTER CONSULTATION WITH LOCAL MEDICAL PROFESSIONALS AND DISTRICT COUNSEL AND CONSIDERATION OF THE CURRENT STAKEHOLDER SURVEY, THE LONOKE SCHOOL DISTRICT'S POLICY CONCERNING MASKS IS AS FOLLOWS:

SHOULD THE WEEKLY AVERAGE OF COVID-19 POSITIVE CASES AND/OR THOSE QUARANTINED MEET OR EXCEED 10% OF LONOKE COUNTY, THE DISTRICT WILL IMPLEMENT A MASK MANDATE FOR THE FOLLOWING WEEK OR UNTIL THE WEEKLY AVERAGE GOES BELOW 10% OF THE TOTAL POPULATION OF THE COUNTY.

MASKS SHALL BE PROPERLY WORN BY ALL SCHOOL DISTRICT EMPLOYEES,

STUDENTS AND VISITORS WHILE INSIDE ANY SCHOOL DISTRICT BUILDING, BUS, VAN, OR OTHER VEHICLE. PROPERLY WEARING A MASK FOR PURPOSES OF THIS POLICY MEANS COVERING THE MOUTH AND NOSE WITH A MASK, AT ALL TIMES, EXCEPT WHILE EATING, DRINKING OR TAKING MEDICATION.

THE DISTRICT ADMINISTRATION SHALL PROMPTLY PROVIDE NOTIFICATION TO ALL EMPLOYEES, STUDENTS AND PARENT/GUARDIANS OF STUDENTS THAT THE MASK REQUIREMENT IS IN EFFECT OR BEING DISCONTINUED.
